AMENDMENT OF INDENTURE OF RESTRICTIONS TOWN AND COUNTRY SOUTH PLAT TWO

WHEREAS, Vescovo Building and Realty Company, a corporation, is the owner of a certain tract of land described as follows:

TOWN AND COUNTRY SOUTH PLAT TWO DAILY #230 ON OCT. BER, 21, 1970.

AND WHEREAS, Vescovo Building and Realty Company, as such owner has caused George W. Kropp and Associates to plat and lay out the same in lots as a subdivision under the name of TOWN AND COUNTRY SOUTH PLAT TWO SUBDIVISION filed simultaneously with the filing of these restrictions in the Office of the Recorder of Deeds of St. Louis County, Missouri, which said plat and the land shown thereon shall become and be part of this instrument with the same force and effect and is made a part hereof, and,

WHEREAS, on the 24th day of October, 1966, an "Indenture of Restrictions" was recorded in Book 6091, Page 388 in the Office of the Recorder of Deeds of St. Louis County, Missouri for a tract of land known as TOWN AND COUNTRY SOUTH PLAT ONE and therein provided that said indenture would also include tracts two, three, etc. of TOWN AND COUNTRY SOUTH, and,

WHEREAS, the owner of all the real estate described in this "Indenture of Restrictions" is desirous of amending said restrictions to be applied only to TOWN AND COUNTRY SOUTH PLAT TWO, or any subsequent plats required to subdivide the remainder of the tract as described in the "Indenture of Restrictions" recorded in Book 6091, Page 388, and,

WHEREAS, the owners of all the lots in TOWN AND COUNTRY SOUTH PLAT ONE shall not be bound by this "Amendment of Indenture of Restrictions", and,

WHEREAS, the present and future owners of TOWN AND COUNTRY SOUTH PLAT THREE, etc., shall be bound by the original "Indenture of Restrictions" along with this amendment or any future amendments.

NOW THEREFORE, notwithstanding any other condition contained in the "Indenture of Restrictions" in Book 6091, Page 388 of the St. Louis County Records, the trustees shall make suitable provision for compliance with all subdivision and other ordinances, rules and regulations of St. Louis County or any municipality of which the subdivision may become a part, including but not limited to the maintenance and operation of street lighting and Cul-de-Sac Islands, and for such purposes shall not be limited to the maximum assessment provided for in Book 6091, Page 388 of the St. Louis County Records.
